Your balance for payment for this contract is due on or before your event unless stated otherwise.

TRUE BELIEVERS ENTERTAINMENT agrees to provide photo booth service for the Client on the indicated date, time and location. However, in some situations operations may need to be interrupted for maintenance of the photo booth.

PAYMENTS:

A non-refundable deposit of \$100.00 is required in order to reserve the date of your event. Final payment must be made on or before the date of your event. If paying on day of event, payment must be paid before the start of service in cash. **Make checks payable to : TRUE BELIEVERS ENTERTAINMENT.** Client will pay a \$50.00 fee for all returned checks.

If the client uses equipment in excess of the service period agreed, the overage in rental time will be billed to the client at the following rates:\$125/hr. Payment for any overage in time must be paid before additional hours are provided.

DATE CHANGES AND CANCELLATIONS

Any request for a date change must be made in writing at least fourteen days in advance of the original event date. Change is subject to photo booth availability and receipt of a new Service Contract. Failure to notify us of your event cancellation will result in a 100% penalty of the entire balance of the event and will be due to True Believers Entertainment.

ACCESS, SPACE & POWER FOR PHOTO BOOTH:

Event location must be accessible for photo booth delivery & setup one hour before the start of event. If your event is not on ground level and there is no elevator access then a \$50.00 stair charge will apply. The client agrees to provide sufficient, electrical power supply (110 v, 10amps 3 prong outlet) within 20 feet of the designated setup location. Client will also arrange for an appropriate space (10'x10') for the photo booth at event's venue.

DAMAGE TO THE EQUIPMENT

Client acknowledges that he or she is responsible for any damage or loss to True Believers Entertainment's equipment caused by: a) Any misuse of the equipment by Client or its guests, or b) Any theft of the equipment or accessories.

INDEMNIFICATION

Client agrees to, and understands the following: a) Client will indemnify provider against any and all liability related to Client's event during or after Client's event. Client will indemnify True Believers Entertainment from the time of service and on into the future, against any liability associated with Client. b) Client will indemnify True Believers Entertainment against any and all liability associated with the use of pictures taken within True Believers Entertainment's Photo Booth its representatives, employees or affiliates at Client's event.

MODEL RELEASE

Client agrees to and understands the following: All guests using the photo booth hereby give True Believers Entertainment the right and permission to copyright and use, photographic portraits or pictures of any photo booth user who may be included intact or in part, made through any and all media now or hereafter known for illustration, art, promotion, advertising, trade, or any other purpose. In addition I, hereby release, discharge and agree to save harmless True Believers Entertainment, from any liability, that may occur or be produced thereof, including without limitation any claims for libel or invasion of privacy. MISCELLANEOUS TERMS

In the event True Believers Entertainment is unable to supply a working Photo Booth for at least 80% of the service period, Client shall be refunded a prorated amount based on the amount of service received. If no service is received by Client due to circumstances out of True Believers Entertainment's control, True Believers Entertainment's maximum liability will be the return of all payments received from Client. True Believers Entertainment is not responsible for any consequential damages or lost opportunities upon breach of this agreement.
