Deposit: TRUE BELIEVERS ENTERTAINMENT agrees to provide a Fun-Filled and Entertaining event for the organization or party on the indicated date, time, and location for the fee listed on the previous page. Note: A non-refundable deposit of \$100.00 is required in order to reserve the date of your event. It may be applied to a different date/event if requested in writing a minimum of 14 days before the scheduled event.

Payments

We accept cash, cashier's check, credit cards and money orders.

Make checks or money orders payable to: TRUE BELIEVERS ENTERTAINMENT.

Overtime: At your event, each additional hour of Entertainment will be \$75.00 per hour. **OVERTIME MUST BE PAID UP FRONT, PRIOR TO THE START OF OVERTIME!**

Final Payment of Balance Due:

Note: Final payment must be made on or before the date of your event. If paying on date of event, payment must be paid before start of service in cash. No checks will be accepted.

Additional Terms:

Notice of cancellation must be given two weeks prior to your event. Failure to notify us of your event cancellation will result in a 100% penalty of the entire balance of the event and will be due to True Believers Entertainment. If the starting time of your event is delayed because of circumstances beyond our control, such as hazardous weather, poor road conditions, mechanical problems, acts of God, War, fire, or any uncontrollable reasons, True Believers Entertainment will attempt to fulfill this Performance Agreement by adjusting the time or the fees accordingly, in order to satisfy you.

In the event the DJ assigned to this Event is unable to perform due to illness, accident, equipment failures or otherwise, True Believers Entertainment shall use its best efforts to find a qualified replacement DJ, equipment or to otherwise perform hereunder. If True Believers Entertainment is unable to locate a replacement DJ or replacement equipment, and therefore fails to perform hereunder, the Client shall receive a full refund of any amounts paid (including Deposit) within thirty (30) days after the Event Date. The parties agree that refund of its payments made shall be Client's sole and exclusive remedy in either law or in equity for True Believers Entertainment's failure to perform hereunder.

It is understood that if this is an outdoor ("Rain or Shine") event, True Believers Entertainment's compensation is in no way affected by inclement weather. For outdoor performances, Client shall provide overhead shelter for setup area. The DJ reserves the right, in good faith, to stop or cancel the performance should the weather pose a potential danger to him/her, the equipment, or audience. Every effort will be made to continue the performance; however, safety is paramount in all decisions. True Believers Entertainment's compensation will not be affected by such cancellation.

True Believers Entertainment will not tolerate inappropriate behavior of attending guests. Any such behavior that might cause harm to the equipment and/or staff of True Believers Entertainment may warrant immediate termination of the event, with no refund of any fees. If the Client is able to resolve the threatening situation in reasonable time (maximum of 15 minutes) True Believers Entertainment shall resume performance in accordance with the original terms of the agreement.

Requirements:

We require the following at each event: A **minimum of 10 feet** between the wall and the dance floor to set up our equipment. 1 - Standard AC Outlet (with 2 plugs) from a reliable power source within 20 feet (along the wall) of the setup area. This circuit must be free of all other connected loads. Any delay in the performance or damage to True Believers Entertainment equipment due to improper power is the responsibility of the Client. Two circuits are preferred, when possible. Additional outlets on SEPARATE circuits for lighting (if contracted) are required.

Event location must be accessible for setup one to three hours prior to start of event, depending on service chosen. If your event is not on ground level and there is no elevator access then a \$50.00 stair charge will apply.

If this Performance Agreement is acceptable to you, please sign and date the bottom and then return it along with your deposit (or entire balance) to reserve your date. This agreement is not binding until signed by both Client and True Believers Entertainment. Oral agreements are non-binding. You will receive a copy of this Performance Agreement for your records, once we receive deposit and signed Agreement.

By signing this agreement, you also give True Believers Entertainment the right to take pictures and/or video tape your event in which we may use for promotional and other business purposes, unless you indicate to us in advance that this is not allowed.
